



## Summer Enrichment Program Intern Educator Position Description

### About This Role:

K-State Extension (KSE) Pawnee County is seeking two Interns to serve as Youth Development Educators within the Kansas 4-H Summer Enrichment Program to provide high-quality local and regional 4-H programming to Kansas youth. Interns will be responsible for planning, organizing, facilitating and teaching lessons to youth with research-based curriculum provided by K-State Extension.

This position is a full-time (up to 40 hours/week), 12-week internship that will run approximately May 18, 2026 – August 8, 2026. Interns will travel and have an overnight stay for the state-wide internship training May 26-28, 2026.

### Responsibilities:

- Plan, coordinate, promote, teach and evaluate educational programs under the direction of the local Extension Agents and state-wide Engagement Leader team.
- Partner with community groups and schools for summer programming; Educators will supply, plan, coordinate and teach programs as requested by these partners.
- With help from local extension staff, Educators will market communications about programs and events through various platforms and communication sources (social media, email, newspaper, 4-H Newsletter, local school districts, libraries, 4-H Clubs, etc.)
- Coordinate and teach Extension programs through 4-H summer camps, day camps, and other youth events through local extension office.
- Distribute, collect and report on program evaluations for programs delivered.
- Complete program reports tracking participants engagement in programming.
- Encourage youth and volunteer recruitment in the local 4-H program.
- Participate in professional staff development (In-person training, weekly Zoom meetings or others that may become available.)
- Complete other responsibilities assigned by the local extension agent and/or Engagement Leader Team to do with the 4-H grant program.

**Minimum Qualifications:**

- Requires a high school diploma or equivalent.
- Must be a legal adult; 18 years of age.
- Work experience with youth and/or educational or leadership background.
- Ability to communicate effectively, both orally and in writing, with individuals, groups and through mass media and social media.
- Possess computer skills including email, internet, and Microsoft Office Programs.

**Preferred Qualifications:**

- Experience working with individuals, groups, and co-workers to accomplish individual and/or group goals, as evidenced by previous leadership roles.
- Experience working with a variety of audiences.

**Other Requirements:**

- Requires a valid driver's license, proof of vehicle insurance and reliable transportation and a willingness to travel in state to achieve program objectives including night and weekend events.
